29th DAE Safety & Occupational Health Professionals Meet at Rawatbhata Rajasthan Site (RR Site) during Dec 17-19, 2012.

The 29th DAE Safety & Occupational Health Professionals Meet (SOHPM) was jointly organized by Atomic Energy Regulatory Board (AERB), Mumbai, Nuclear Power Corporation of India Limited (NPCIL) and Heavy Water Board (HWB), at New Community Center, Rawatbhata during December 17-19, 2012. The SOHPM is organised annually with different themes on Industrial Safety and Occupational Health by AERB with a Department of Atomic Energy (DAE) unit to promote and motivate Safety and Occupational Health aspects in DAE units under the regulatory control of AERB. The theme for this year's three day Meet was "Emergency Preparedness for Chemical Industries and Emergency Medicine". A Monograph on "Hazardous Chemicals & Emergency Preparedness and Emergency Medicine" was released by Shri R. Prakash, Chairman & Chief Executive, Heavy Water Board. Shri K. C. The winners of this year Environmental Protection Awards are Indian Rare Earths Limited (IREL), Chavara, Narora Atomic Power Station and Kakrapar Atomic Power Project 3&4. Shri Bajaj also released the technical proceedings, commemorating the Meet and delivered the Inaugural Address. One of the major highlights of this year's Meet was that the Dr. S.S. Ramaswamy Memorial Endowment Lecture was delivered by Shri B. Bhattacharjee, Member, National Disaster Management Authority (NDMA), NewDelhi on 'Science and Technological Inputs for Emergency Preparedness in Chemical Industries'. Presentations were made by various participants on Industrial & Occupational Health Statistics, Serious and Near Miss Accident cases, Hazard Identification & Risk Assessment, Process Safety, Hazardous Waste Management, Occupational Health and Emergency Medicine etc. The technical sessions were interactive with active participation of the safety and occupational health professionals. There were about 50 presentations on the Emergency Preparedness and Emergency Medicine and other topics by various professionals from DAE units and AERB

On the third day, there were presentations on 'Contract Safety Management & other topics'. The Meet was concluded by a Valedictory Session, where in prizes for winners of Poster, Cartoon and Slogan Competitions conducted amongst DAE Employees were distributed.
