
Sir,

2. Notice of Preliminary Hearing was also published in the newspaper in Free Press Journal and Mathrubhumi on August 31, 2021. Efforts were also made to serve the notice through Office-in-Charge, Low Level Radiation Research Laboratory (LLRRL), Kollam, Kerala – 691001, since there is a unit of BARC in Kollam, Kerala. However, this was returned back by the Office-in-Charge, mentioning that it was beyond his mandate. Since the Charged Officer was not present on early occasion i.e. August 24, 2021, it was decided to proceed with the enquiry ex-parte.


3. The Preliminary hearing commenced and concluded on September 08, 2021 at Room No.206, Administration Division, AERB, Niyamak Bhavan-A, Anushaktinagar, Mumbai – 400094

4. The presenting officer is directed to offer inspection of documents listed in Annexure-III to the charged officer in the office of APO-R, Room no.202, Administration Division, AERB, Niyamak Bhavan-A, Anushaktinagar, Mumbai – 400094 on September 21, 2021 at 14:00 hrs. He should also supply to the charged officer copies of the listed documents.


5. The charged officer should thereafter submit by October 01, 2021 list of additional documents he wishes to inspect and list of witnesses, he would like to examine, in his defence. Full particulars of the documents showing the custody and relevance to the charges must be furnished. In the case of witnesses, the complete postal addresses, the name and designation of their controlling authorities, if they are in public employment, and their relevance to the charges has to be furnished.

6. The charged officer should also intimate name and designation and address of the employee, with full details of the controlling officer who will assist him during the inquiry.

7. The next date of hearing will commence from October 18, 2021 and will be held till completion on day to day basis at Room No.206, Administration Division, AERB, Niyamak Bhavan-A, Anushaktinagar, Mumbai – 400094.
