AERB meets a delegation from French Regulatory Authority

A delegation from French Regulatory Authority (ASN) led by Mr. Andre' Claude LACOSTE, ASN President met Atomic Energy Regulatory Board (AERB) Chairman, Mr. S.S. Bajaj and other senior officials on Feb.29,2012 at Mumbai to discuss on the common safety issues and also issues related to emergency preparedness and management of post accidental situations. Safety reviews carried out in both the countries for all the nuclear installations after Fukushima accident were also discussed and similarities in approach were noted.

A workshop was also conducted subsequently for the next two days with safety experts from both the countries presenting the latest practices adopted by them and also sharing the past experience. Large number of scientists and engineers from AERB, NPCIL (Nuclear Power Corporation of India Limited) and BARC (Bhabha Atomic Research Centre) participated in the workshop.

This meeting and the workshop have provided a good platform for the mutual sharing of the experiences and benefitted the regulatory bodies and the safety experts from both the countries.

Both the countries have conducted such meetings and workshops in the past also under the Nuclear Safety Co-operation Arrangement between the two organizations that was signed in July 1999 and further renewed in 2005 and 2010. The previous workshop under this information exchange programme was held during November 22-23, 2010 in Mumbai.
